Note: Dancers living far from a club can be a member of CSRDS through a special “Nova Scotia Dancers” club. Excerpt from January 2009 Executive Minutes regarding Members at Large: “A motion was made by Dottie Welch that the Federation consider establishing a club called Nova Scotian Dancers to accommodate dancers who do not have a club within a 50 km radius of their home. Membership in this club will enable dancers to be NS Federation members and be covered by National Society Insurance. Membership in the club will be subject to Federation Executive approval and will entail an annual membership fee of \$10 per dancer. Motion carried.”

Motion by Dottie W., 2<sup>nd</sup> Harold R, to revise the arrangement discussed in the January 2009 minutes, to say “Dancers who wish to become members of CSRDS but cannot do this through a club, may do so directly through the Federation.” Passed

**National Festival 2014:** Plans for the Canadian National Convention/Festival 2014 continue to progress. The venue will be the Ottawa Convention Centre on 17-19 July, 2014.
